



**ANDY COMMUNICATES WITH FELLOW
MARS EXPERIENCER MICHAEL RELFE**

*In February 2010, Andrew D. Basiago, president of the Mars Anomaly Research Society (MARS), exchanged e-mails with Michael Relfe, author of **The Mars Records**, which detail his 20-year odyssey on Mars. According to Relfe, he teleported to Mars at age 20, worked there from 1980 to 2000, and then was time traveled back in time 20 years to conceal his activities on behalf of the secret Mars colony. Relfe believes that mind control was used to hide his Mars experiences from his conscious mind. He is an advocate of the proposition that Mars experiencers should undergo a clearing process involving bio-feedback that he has developed to bring "black" project activity on the Red Planet into conscious focus.*

Dear Michael,

My discovery of life on Mars encompasses the fact that Mars has a biosphere and is the site of many ancient artifacts.

It is an ongoing research project in natural history that is identifying humanoid beings, animal species, carved statues, and built structures on the surface of Mars.

It then uses these findings to make a case for Mars being protected from visitation, exploration, habitation and colonization by human beings from Earth, including US personnel presently on Mars, via international treaty.

It does not constitute a proof that human beings from Earth have not yet been to Mars – only that indigenous life forms and archaeological resources exist there in abundance. It then presents photographs and text describing what those life forms and ancient artifacts are.

Indeed, in the realm not of natural history but of deep politics, I, like you, am a Mars experiencer. I have been narrating my Mars experiences in a growing body of radio interviews.

I twice teleported to Mars in 1981 from a "jump room" at a CIA facility in El Segundo, California.

I was trained for these missions by a CIA officer named Courtney M. Hunt, whose identity as a CIA officer has been verified by intelligence community ethicist Dr. Jean Maria Arrigo and career Army security attaché Captain Ernest Garcia, a veteran of many classified projects.

I have also questioned Hunt's ex-wives B.J. Hunt and Linda Hunt and his son Robert Hunt to establish that Mr. Hunt was what he said he was, namely, a career CIA officer, and that, therefore, my memories of visiting Mars through his facilitation were the result of *bona fide* interactions with a CIA employee.

My first trip to Mars via teleportation was made in July 1981 by myself. The "jump room" arrived at an underground location and I walked up a concrete stairwell to reach the surface. I walked through the eye sockets of a skull on the surface, stepped out onto the surface, was met by three human beings from Earth, and stood around for about an hour, before I was told that I could leave and teleport back to Earth. The atmosphere was breathable but thin, the sky a very pale blue.

My second trip to Mars via teleportation was made in August 1981 in the company of Mr. Hunt. We used the same "jump room" at the CIA facility in El Segundo to reach Mars and arrived at the same underground location. When we walked up the stairs and stepped out onto the surface, we walked around on the surface for three or four hours. We visited an old stone house (like one might find in rural Arizona) and interacted with a colonist from Earth.

I have narrated these two trips extensively now on radio. They are also contained in a 390-minute interview entitled "A Conversation with Andrew D. Basiago" that was produced by Jessica Schab that has been posted on the Internet at www.youtube.com.

So, make no mistake, my position is two-fold. First, I am showing in my research papers published by MARS that Mars is inhabited. Second, I have joined the growing cadre of individuals who are disclosing their Mars experiences so that humanity can know not just that Mars is inhabited but that human beings from Earth are among the life forms that inhabit Mars.

I affirm evidence like the photograph revealed by Bob Dean at the European Exopolitics Summit in July 2009, which shows an aerial view of a base on Mars.

I would add that my account also corroborates your account. While I was not time traveled back to the past after working on Mars for 20 years, as you describe, I did reach Mars via a form of quantum access, a teleportation-based "jump room" of the kind that has been described by other Mars experiencers.

In the future, I would like to interview you about your Mars experiences for "The Annals of MARS." Meanwhile, I would like to post a link at www.projectmars.net giving readers the opportunity to download your four free e-books.

In closing, let me both thank you for writing to me about this vital subject and for revealing your concern about the effects of my interaction with the US government on me.

Let me say that after now spending 10 years investigating my childhood experiences in Project Pegasus, which culminated in my several trips to Mars in 1981, I am quite "clear" about the nature of my experiences on behalf of the US government and am waging a truth campaign to communicate them to others.

I hope that we can be allies in the cause of enabling the people of Planet Earth to possess the true natural history of their solar system, which includes the fact that human beings from this planet are already present on Planet Mars.

Dear Michael,

By the way, I find your comment "see what they have really done to you" very presumptuous and, frankly, offensive.

I am familiar with your story and the fact that it includes the unhappy element of you being brainwashed to conceal the 20 years of missing time that you spent working on Mars.

Mine, however, is not a case of mind control or recovered memory.

While brainwashing was used to try to make me forget what I experienced in Project Pegasus when I was a child, I successfully resisted it and never forgot or repressed what happened to me in the program.

I also never forgot about going to Mars in 1981. Rather, I decided to not talk about my trips up there for fear nobody would believe me and out of concern there might be retaliation against me if I did speak about them. As my truth campaign unfolded, I decided that I should come forward and tell the whole truth with a view to the notion that full disclosure is the only true disclosure there is.

Hi Andrew,

Thank you for your two letters. It is difficult to begin communication with someone that I have already offended, however, I will try!

Your term “brainwashing” as applied to those involved with military/alien interaction is rather broad and non-specific. In my experience, a more accurate description would be “memory blocking security protocols.” I refer to those procedures in that way as there are many negative stereotypes associated with the term “brainwashing” (change in personality, etc.).

You find my assumption that you have involvement with these groups that you are not aware of to be “presumptuous.” That is possibly true. However, please consider it from my position for a moment.

From our over 14 years of experience, these are our assumptions. Humans are a psychic species. Human metaphysical abilities are active or inactive and are concentrated in certain family lines. As part of your data collection, we thought you might be interested in what she found for you. There are no guaranties; however, I have found in the last 12 years that Stephanie's remote muscle testing has been shown to be remarkably accurate.

We get that you are a P13. That means someone with 13 metaphysical abilities. I am also a P13. Stephanie is a P17. The highest I have ever personally met is a P23. We know a P31 by distance kinesiology. This does not in any way indicate any "horsepower" rating of any ability.

We get that your abilities are: (Found in this order)

1. Empath
2. Remote viewer
3. Healer
4. Seer of the future (using a machine)
5. Fixer of equipment (that is impossible to fix)
6. Analyzer of problems holographically
7. Sender of messages through time (using a machine)
6. Finder of new universes
7. Inventor of new technology (tests as the most rare/valuable ability)
8. Not identified

Note: Between 7 and 8, there was a few minutes delay. Original testing was that #7 was the last one we had a name for so we almost stopped. Then, Stephanie checked for "interference." This may be because they are beyond our knowledge.
